When you create a Hubbs account or use Hubbs, you agree to these terms.

Hubbs is one of the [GoEducate products](#) provided to you by GoEducate Inc. These Terms of Use therefore constitute an agreement between you and GoEducate Inc. These Terms of Service ("Terms") govern your access to and use of Hubbs and GoEducate websites and applications (The "GoEducate Service").

Your access to and use of the GoEducate Service is conditioned on your acceptance of and compliance with these Terms. By accessing or using the GoEducate Service you agree to be bound by these Terms.

IF YOU ARE A PARENT OR GUARDIAN AND YOU PROVIDE CONSENT FOR YOUR CHILD TO REGISTER WITH THE SERVICE, YOU AGREE TO BE BOUND BY THESE TERMS OF SERVICE IN RESPECT OF SUCH CHILDS' USE OF THE SERVICE.

### 1. Eligibility; Accounts

1. The Service IS not available to (A) any Users previously suspended or removed from the Service by GoEducate OR (B) ANY PERSONS UNDER THE AGE OF 13 WHOSE REGISTRATION HAS NOT BEEN APPROVED BY A LEGAL PARENT OR GUARDIAN.

### 2. Account

1. In order to use certain features of the Service, you must register for an account. You may be asked to provide a password in connection with your account. You are solely responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and You agree to accept responsibility for all activities that occur under your account or password.
